


Q1 How many attorneys in your firm?



Q2 In what region(s) are you located?



Q3 Most law firms are planning a phased return. What percentage do you expect to return in your “first wave?”



Q4 Will you implement reconfigured work schedules/or shifts?



Q5 If you furloughed employees, do you plan to bring them back immediately?



Q6 Will you perform deep cleaning and disinfection prior to allowing employees to return?







Q9 Will clients be screened prior to entering your office premises?



Q10 What engineering changes will be made for your social distancing plan? (Check all that apply)



Q11 Have you created a return-to-work plan?


